1 Introduction

This document is intended for financial institutions, software partners and invoice issuers who use the SIX Validation Portal to verify QR-bills.

1.1 Purpose

This document contains the process description and step-by-step instructions for the SIX Validation Portal. Any special features for validating a QR-bill are described and explained in detail.

1.2 Link and registration

All of the instruction steps and information contained in this document refer to the SIX Validation Portal for SIX QR-bills, which can be found at:

Registration is required in order to use the SIX Validation Portal. Users can log in to the SIX Validation Portal as soon as their accounts are activated.

We kindly ask you to read our user instructions before starting validations. The instructions contain information and tips including permitted formats, prescribed encoding and other topics.

2 SIX Validation Portal process overview

The process overview serves to visualize the registration and login as well as validation in the SIX Validation Portal.

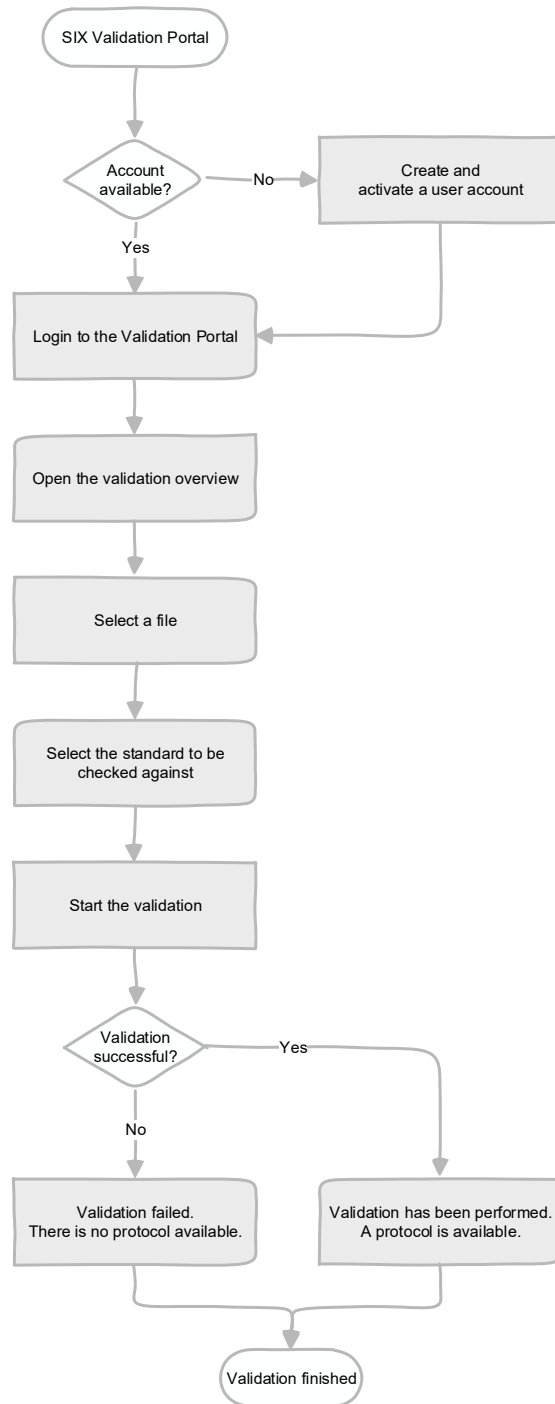


Figure 1: SIX Validation Portal process overview

3 Validation principles

3.1 Validation process

To validate files, switch to the validation overview via the “Validation” tab.

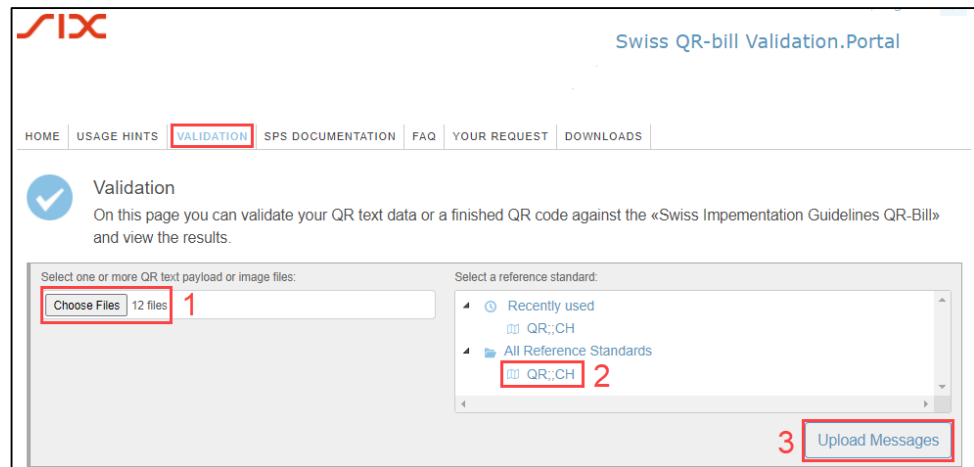


Figure 2: Overview of how to upload files

- Select and open one or more files via “Choose Files” (1).
- On the right side, select the standard (2) for checking the file(s) against.
- Click “Upload Messages” (3) to complete the process.

Currently, only one standard is available for selection for the QR-bill. However, our Validation Portal offers the possibility to provide several standards from which you can individually choose the standard that suits you for each file you upload.

Once the files are uploaded, there are several options to validate or manage them.

- To validate a single file, select “Validate Now” (4) on the right side of that file.
- To validate all uploaded files, select all of the entries (5) using the checkbox on the upper left side. If only particular files are to be validated, they can be selected using the corresponding checkboxes. Then click on the “Validate Selected Messages” option (6) and start the validation by clicking on “Execute” (7).
- Each uploaded file also has additional options (8). As well as allowing you to view and download the file, you can delete it or change the standard against which the file is to be validated.

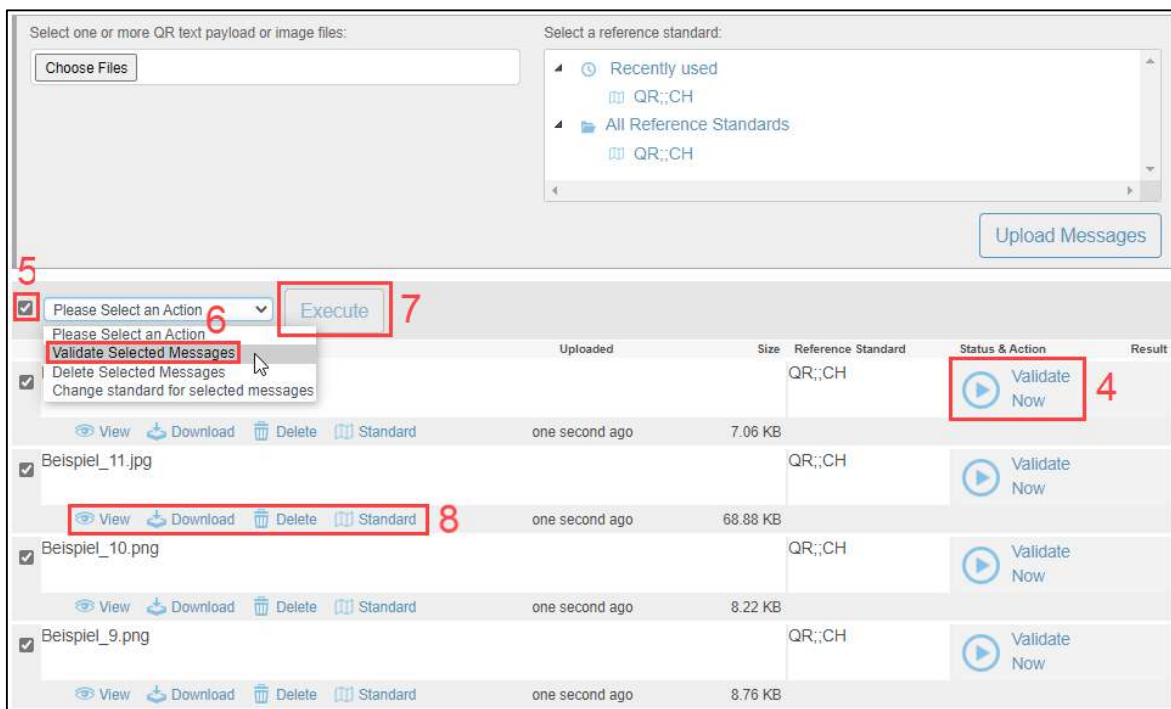


Figure 3: Overview of uploaded files

3.2 Possible validation results

Please note that due to the various software applications and hardware scanners used, the processing and/or validation results may vary on several points.

3.2.1 Validation without errors

A green test result with the status “Validation complete” means that the file could be successfully validated and does not contain any errors.

3.2.2 Validation with errors

A red test result with the status “Validation complete” means that the file could be validated, but that it does contain errors. An indication of how many errors or notes are involved is directly visible in the overview.

3.2.3 Validation failed

If a file cannot be validated, the status “Validation failed” is displayed. Since the validation could not be successfully completed, no protocol is available.

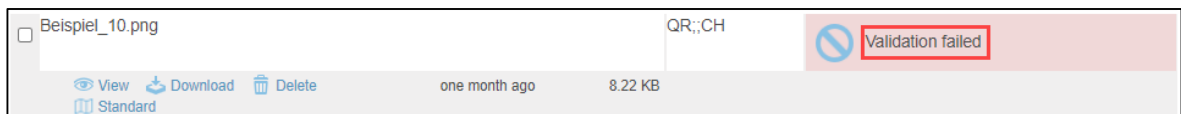


Figure 6: Validation failed

4 QR image

The QR image is the actual QR code that is present on the QR-bill. It is not possible to upload QR-bill in its entirety. If you have a complete QR-bill in a digital form, select and cut out the QR image and save it in one of the permitted image formats. Generally speaking, any screenshot or snipping tool is suitable for this purpose.

The validation of the image file works the same as described in chapter 3.1. If the validation of the QR Code image fails it is suggested to validate it as a text. To do so, the content of the QR Code needs to be transferred to .txt-file and re-validated.

4.1.1 QR image validation process overview

The process overview is used to visualize the validation of a QR image.

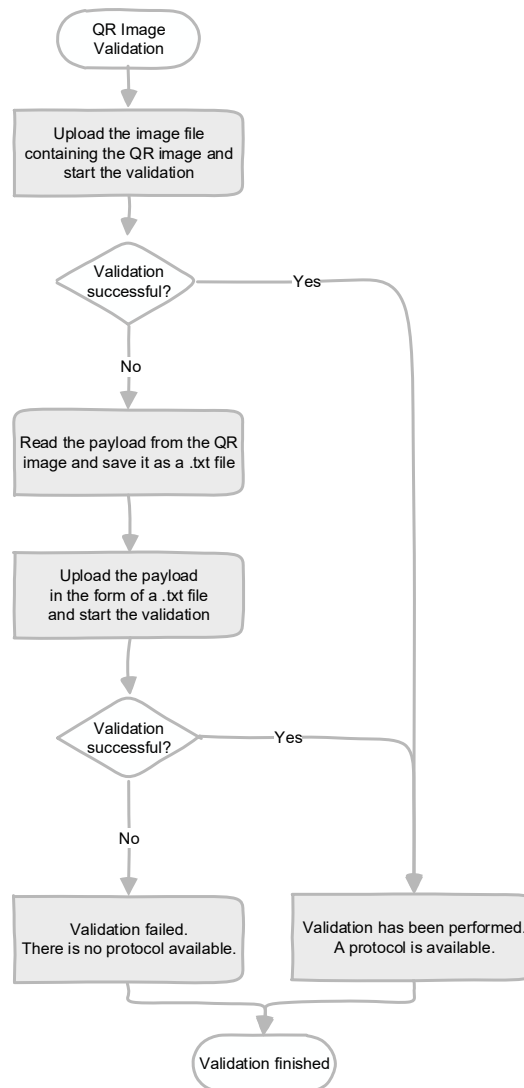



Figure 7 Overview of the QR image validation process
